#### Principal's Report

Principal Contreras introduced himself and shared his priorities for the upcoming year, which included review of instruction, guidance and Diversity. He discussed focus on the existing students who will be submitting to Intel/Regeneron, as well as the development of a strategic plan that begins engagement earlier than spring of junior year. He noted that the PSAT for juniors was no longer being funded by the Dept. of Education. It would cost \$12,000 to administer the test to all juniors.

#### **Executive Director's Report**

Ms. Tepperberg stated that Directory section of our website has new enhancements, allowing alumni to search by industry, company and title as well as the ability to view historical newsletters. The Directory gives alumni the ability to change their contact information directly online rather than submitting emails to the office to update the database. She noted that we recently hired Rachael Biscocho '12 as a Marketing Associate.

Ms. Srugo presented the Proposed 2016-2017 Budget. She noted that new items included StuyPrep and mentoring. Mr. Kim stated the Executive Committee approved this budget.
