



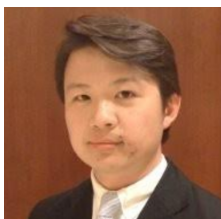
Soo Kim

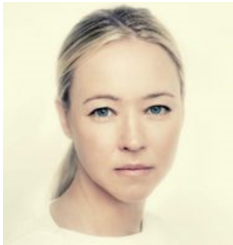
Frances Lopez

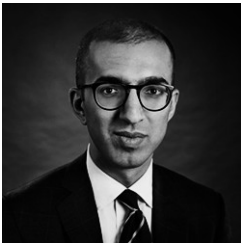
Bart M. Schwartz

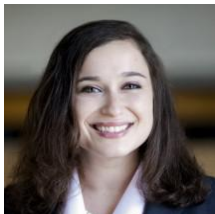
Renee Stevens
